

OFFICIAL CALL Larimer County Republican Central Committee Organizational Meeting

Pursuant to the election laws of Colorado and in accordance with Section XVI of the Bylaws of the Colorado Republican Central Committee and the Bylaws of the Larimer County Republican Central Committee (herein "the Bylaws") notice is hereby given that a meeting of the Larimer County Republican Central Committee (LRC) has been called and shall be held at the following date, time and location:

Saturday, February 8th, 2025 9:00 a.m. Registration begins at 8:00 a.m. Timberline Church South Auditorium 2908 S Timberline Rd. Fort Collins, CO 80525

The primary purposes of the Larimer County Republican Central Committee (LRC) meeting will be:

- 1. To elect LRC Officers for the offices of Chairman, Internal Vice Chair, External Vice Chair and Secretary
- 2. To elect 18 LRC Bonus Members: 9 male and 9 female
- 3. To conduct any other business that may properly come before the LRC

Notice is also hereby given that a meeting of the Republican Legislative District Central Committees will be held for the following single-county districts within Larimer County: HD51, HD52, HD53 and SD14. The district meetings will convene during the recess of the LRC meeting, but not before noon. The primary purposes of the Legislative District Central Committee meetings will be:

- 1. To elect District Officers for the offices of Chairman, Vice Chairman and Secretary
- 2. To designate appropriate vacancy committees for each single-county district listed above as needed
- 3. To conduct any other business that may properly come before the district central committee

Attendance must be in-person or by Proxy. There will not be any arrangements for attending remotely by phone or online.

Regular (voting) members and Ex Officio (non-voting) members of the LRC are defined in Section III-1-A and B of the Bylaws:

- A. REGULAR/VOTING MEMBERS: The regular members of the LRC shall be the Republican precinct committee people from all election precincts within Larimer County, all of the District Captains, if any, all of the Republican Party County officers, including bonus members, the Treasurer, and Finance Chairman, the area coordinator from each county commissioner district, together with the elected Republican County public officials, the Republican District Attorney, and the Republican State Senators and Representatives, the Republican United States Senators and Representatives, the elected Republican State public officials who reside within the County, but a multiple office shall not entitle a person to more than one vote, excluding proxies.
- **B. EX OFFICIO/NON-VOTING MEMBERS:** Ex officio members shall be the designated representative of each auxiliary within the county recognized by the National Republican Central Committee, and the elected officers of the various legislative districts who reside within Larimer County. Ex officio members shall have all the privileges of a regular member except they shall not have a vote unless otherwise a member of the LRC.

A listing of precincts by commissioner district is attached. The eight precincts with no registered voters were not included.

Proxy Information

If you are unable to attend, you may give the enclosed proxy to another member of the LRC in accordance with Section V-3-D of the Bylaws. Section V-3-D states:

Any regular member of the LRC may vote at any meeting thereof by proxy appointed by an instrument in writing and signed by such member. The individual designated by proxy shall be a Republican elector and shall reside in the county commissioner district in which his principal resides, and no one shall carry more than three (3) proxies. A proxy shall be delivered to the Credential Committee prior to the vote to which it applies and shall apply to a single meeting. The proxy may vote only if the regular member is absent at the time of the vote. Any member of the LRC shall have the right to examine the proxies prior to the taking of the vote. All proxies must be dated and signed by the regular member. If more than one proxy is executed by a regular member, the last properly dated executed proxy is the official proxy.
