

# 2026 Resolution Submission Information

Resolutions are statements adopted by the caucus to express shared priorities and perspectives. They guide discussion and advocacy but are not binding rules or automatic mandates.

## How does the Resolutions process work?

- Resolutions can start at your precinct caucus. You may discuss your resolution with your caucus and adjust it before submitting it online.
- If a resolution is approved at the Larimer County Republican Assembly, it moves on to the Colorado Republican Party State Assembly.
- If it is approved at the state level, it may then be sent to the National Republican Party for consideration.

## Who may submit a Resolution?

Any registered Republican in Larimer County who is eligible to participate in the March 3, 2026, precinct caucus may submit a resolution.

## What can a Resolution address?

- Resolutions must address statewide or national Republican Party policy (not county-level issues).
- Each resolution must *cover one topic only*, be clear and concise, be no longer than one page.

## IMPORTANT DATES

### Tuesday, March 3, 2026 – Precinct Caucuses

Present your resolution to get additional sponsors, feedback, and make final edits.

### Monday, March 9, 2026 – Submission Deadline

- Acceptable formats: Plain text (email text or .TXT files) or .DOC or .DOCX files attached to an email
- No paper copies or other formats
- No late submissions

### March 10–16, 2026 – Committee Review

Resolutions Committee reviews all submissions.

### Tuesday, March 17, 2026 – Posted Online

Resolutions are posted on the LCRP website for delegates to review.

### Saturday, March 21, 2026 – County Assembly

Delegates vote on resolutions.

Passed Resolutions move on to the state assembly meeting for consideration.

## How to Submit a Resolution

Your resolution must include your:

- Full legal name
- Full name of additional sponsors of the resolution
- Home address
- Phone number
- Email address
- Precinct number

### Format for the body of the Resolution

- **Up to 3 “Whereas”** statements (background, optional)
- Followed by **“Therefore, Be It Resolved”** (the action)
- Keep it short. No long paragraphs.
- Must not:
  - Contain slanderous, obscene, or profane language
  - State a complaint without proposing a resolution
  - Be unclear to the extent that a meaningful vote is not possible, or contain similar substantive defects.
  - Exceed a single page in length
  - Be submitted as draft legislation or boilerplate statutory language rather than a resolution

**Whereas**, members of the Republican Party of Colorado increasingly conduct party business from homes where cats are present, attentive, and unimpressed; and

**Whereas**, cats routinely appear during important discussions, providing calm indifference and reminding everyone that deadlines are *aspirational*;

**Therefore, Be It Resolved**, that cats be acknowledged as unofficial observers of party operations, offering perspective, patience, and occasional keyboard supervision.

## **The Resolutions Committee**

- The Chair and members of the Resolutions Committee are appointed by the Chair of the Larimer County Republican Party.
- The Committee shall consist of 3 to 9 members, including the Chair, at the discretion of the LCRP Chair.
- All Committee members must be registered Republicans and legal residents of Larimer County.
- Each Committee member has one equal vote when reviewing resolutions.
- A resolution may not be rejected solely because Committee members disagree with its content.
- A Resolution may be rejected if it:
  - Contains slanderous, obscene, or profane language
  - States a complaint without proposing a resolution
  - Is unclear to the extent that a meaningful vote is not possible or contains similar substantive defects
  - Exceeds a single page in length
  - Is submitted as draft legislation or boilerplate statutory language rather than a resolution
- Resolutions approved by a majority of the Committee shall be forwarded to the Larimer County Republican Assembly and Convention.
- The Committee shall not change the meaning or substance of any submitted resolution.
- Similar resolutions may be consolidated into a single resolution, and minor edits for format, spelling, or clarity are permitted.

## **Notifications and Remedies**

- When time permits, the Committee Chair will attempt to notify submitters if a resolution is rejected due to content issues, missing information, improper format, or missed deadlines.
- When time permits, submitters will be notified if their resolution is consolidated with a similar submission.
- Corrections are not guaranteed, and resolutions may be rejected for failure to comply with these rules.
