



**OFFICIAL CALL LETTER
FOR THE
2026 LARIMER COUNTY REPUBLICAN ASSEMBLY AND
HOUSE DISTRICT 51, 52, 53 ASSEMBLIES AND *SENATE DISTRICT 15**

I. Pursuant to the Bylaws and Rules of the Colorado Republican Party, the Bylaws and Rules of the Larimer County Republican Central Committee, and Colorado Revised Statutes §1-4-601 and §1-4-602, notice is hereby given that the **Larimer County Republican Assembly** shall be convened beginning at **9:00 AM on March 21, 2026, at Message of Life Ministries, 605 18th St SW, Loveland, CO 80537**. Check-in and credentialing for this Assembly will begin at 7:30 AM.

The principal purposes of this Assembly and Convention of Larimer County Republican Delegates shall be:

- To ratify the election of precinct committeepersons;
- To nominate and designate Republican candidate(s) to the 2026 Primary Election ballot for the offices of County Commissioner (District 1), Sheriff, Treasurer, Clerk and Recorder, Coroner, Surveyor, Assessor;
- Vote on resolutions submitted to the Assembly pursuant to County Party bylaws and rules;
- To ratify delegates and the order and promotion of alternate delegates to the following:

- To designate the 2026 Larimer County Republican Candidate Vacancy Committee and
- To conduct all other business of the Republican Party, that may lawfully come before this Assembly of delegates.

Notice is also given on behalf of the respective District Chairman of State House Districts 51, 52, and 53 that the single-county Republican District Assemblies shall be convened in connection with this County Assembly for the purpose of nominating and designating Republican candidates to the 2026 Primary Election ballot, designating the 2026 Republican House District Candidate Vacancy Committees and conducting all other business of the Republican Party, that may lawfully come before such an Assembly of delegates. Delegates and Alternates to the Larimer County Republican Assembly residing in such Districts shall serve in their respective capacities to such District Assemblies.
