

## **LIBERTY AND LEAD**

### **LARIMER COUNTY REPUBLICAN PARTY**

#### **Participation Rules, Waiver, and Release of Liability**

I \_\_\_\_\_ (name) desire to participate in the Liberty and Lead at Great Guns Sporting, located at 16126 CR 96, Nunn, CO 80648 on 13 June 2026 ("Event"), sponsored by Larimer County Republican Party ("LCRP"). In exchange for LCRP allowing me to attend and/or participate in the Event, and the benefits that I believe that I will gain from attending and/or participating in the Event, I agree to the terms, conditions, and rules set forth in this agreement ("Rules").

#### **DESCRIPTION OF THE EVENT**

1. I understand that the Event consists of Sporting Clays, and moving targets and all related activities, and any associated travel and events, including any possible meals provided to Event participants.

#### **ACKNOWLEDGMENT AND ASSUMPTION OF LIABILITY**

2. I understand that the Event is potentially dangerous and may involve the risk of serious injury, death, and/or property damages to myself or others, and that any injuries that I sustain may be compounded by negligent emergency response or rescue operations undertaken or authorized by LCRP. I am voluntarily participating in the Event with knowledge of the dangers and risks involved.

3. I hereby AGREE to accept and assume all risks of injury, death, or property damage, whether caused by the negligence of LCRP or otherwise.

4. I ACKNOWLEDGE that the use, practice, and competition with firearms carries inherent risk to myself and others. I also ACCEPT the risk for all injury or damages I cause or contribute to during the Event.

#### **WAIVER AND RELEASE OF LIABILITY WITH INDEMNIFICATION**

5. I hereby expressly WAIVE AND RELEASE any and all claims, actions, causes of action, or suits at law or in equity ("Claims"), now or hereafter known against LCRP, and its officers, directors, employees, agents, affiliates, members, sponsoring entities, successors, and assigns (collectively, "Staff"), that are related to any injury, death, or damage, including but not limited to property damage, and that arise out of or are attributable to the Event, whether arising out of the negligence of LCRP and Staff.

6. I AGREE not to make or bring any such Claims against LCRP, or its Staff, and forever release and discharge the Staff from liability under such Claims.

7. I SHALL defend, indemnify, and hold harmless LCRP against any losses, damages, liabilities, deficiencies, Claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind, including but not limited to attorneys' fees, fees, and costs of enforcing any right to indemnification under these Rules, fees and costs of pursuing payment or settlement from any insurance providers, fees and costs incurred by/awarded against any indemnified party, arising from any claim of a third party related to my participation in the Event.

## ENFORCEMENT OF RULES

8. This Agreement supersedes any prior or contrary agreements with respect to the subject matter herein. If any provision of this Agreement is unenforceable in any jurisdiction, such unenforceability shall not affect the other terms herein. This Agreement is binding on and shall inure to the benefit of the Company and its successors and assigns.

9. This Agreement shall be construed in accordance with the laws of the State of Colorado without giving effect to any conflict of law provisions, and any claim or cause of action under this Agreement shall be brought in the courts located in the Larimer County, Colorado and I hereby consent to the exclusive jurisdiction of such venue.

## EVENT RULES

10. These Event Rules (the "Rules") DO NOT allow alcoholic consumption, marijuana, other substance use for shooters *prior* to completing the shooting course at the Event. Shooters, please be responsible for yourself and your team. Infraction will constitute immediate disqualification.

11. ALL GUN ACTIONS WILL REMAIN OPEN and UNLOADED AT ALL TIMES during the Event EXCEPT and UNTIL when on station and shooter is ready to fire. When gun is loaded, keep gun pointed down range at all times. Gun actions will be open and ammunition removed when not on or in between stations.

12. All Firearms Guns shall be unloaded until ready to shoot at the designated stations. Firearms shall only be loaded with the minimum number of rounds or shells needed to complete the designated stations. Firearms may not be loaded beyond the minimum number of rounds or shells needed to complete the designated stations

13. If a gun malfunctions, keep the gun muzzle pointed down range at all times while opening the action.

14. "Backing up" missed targets is not permitted.

15. If the thrower requires repairs, reloading or a station is cold, the shooter is to open the action and remove ammunition until instructed to load.

16. Call "PULL" loudly when calling for Clay targets since shotguns will be going off throughout the course.

17. Trapper should release target or call "no bird" within 3-seconds after target is called. In case of a late target or a "no bird" call, shooter may recall for target when ready.

18. Scorers will count "DEAD", "LOST", "MISS", or "HIT" after each pull and totals at each station. If there is a dispute over a call, the shooter and team captain must question the call immediately. No calls may be disputed after a change of stations. Please keep disputes to a minimum. The scorer makes the final decision on all disputes.

19. For true "Multiple Target" events, if either one or both targets come out broken, shooter may call for another pair and neither target from the first pair will count.

20. A shooter will NOT be allowed to make gun repairs while at stations. The shooter may use a backup gun or a team member's gun to finish the event. No choke or optic changes are allowed once a shooter begins shooting at a station.

21. Shooters must position both feet on the platform while shooting at each event.

22. Check-in begins at 07:30 and closes at 8:30. Program starts at 9:00 and the event will start at 9:30.
23. Parking is permitted at the club house parking area or in the field south of the 50 yd pistol range or the 100 yd rifle range.
24. Course of fire will be 100 rounds of sporting clays. Each participant must bring 100 + rounds of shotgun shells for 15 Clay stations and additional rounds for the optional Warm-Up or Annie Oakley competition. **DO NOT BRING RELOADS. No shot size larger than 7.5.**
25. Prizes will be awarded to Highest Team, High Overall, Two Divisions using Lewis Class, Women and Youth.
- 26.. There will be 45 teams of 4 people. There are no refunds, but teams may substitute for shooters. Score cards will be issued to each team.

**I HAVE READ AND UNDERSTAND THE TERMS OF THIS WAIVER AND RELEASE AND THAT I AM VOLUNTARILY GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE LCRP OR ITS STAFF.**

I acknowledge that this Waiver, Release, and Acknowledgment of Rules must be signed, dated, and delivered to a LCRP representative before I can receive authorization to participate in the Event.
